Before me this date personally appeared ALONSO, JUAN (1854) who being first duly sworn deposes and says that on 4 day of November, (year) 2019 at 200 W MCNAB RD, FORT LAUDERDALE, FL 33309 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

On this date, Lee Feinberg (OF), was involved in a road rage incident with another driver, [REDACTED] (V). [REDACTED] stated after Feinberg cut him off several times, Feinberg slowed down, positioning his vehicle next to [REDACTED]'s. [REDACTED] stated at that point, Feinberg knowingly and willingly produced a handgun and aimed at [REDACTED]. [REDACTED] was in fear for his life and stated his desire for prosecution. Feinberg was placed under arrest and TOT BSO main. [REDACTED] and Feinberg do not know each other.
