ON MONDAY JUNE 10TH, 2024, AT APPROXIMATELY 0813 HOURS, CITY OF MIAMI POLICE (MPD) OFFICERS WERE DISPATCHED TO 431 N.W. 3RD STREET IN EMERGENCY MODE WITH LIGHTS AND SIRENS TO ASSIST CITY OF MIAMI FIRE RESCUE UNITS REGARDING A BUILDING FIRE. AS THE MPD PATROL UNITS WERE ASSISTING WITH EVACUATING THE RESIDENTS OF THE INCIDENT LOCATION, MR. FEDER BIOTTE (VICTIM), WAS LOCATED ON THE SIDEWALK OF N.W. 3RD STREET, DIRECTLY IN FRONT OF THE INCIDENT LOCATION SUFFERING FROM A POSSIBLE GUNSHOT WOUND. TWO WITNESSES, MR. AT APPROXIMATELY 1102 HOURS, MR. SANTIESTEBAN PROVIDED A SWORN AUDIO RECORDED STATEMENT TO DET. M. BARRETO (#44938). MR. SANTIESTEBAN CONFIRMED HE WAS A RESIDENT AT THE INCIDENT LOCATION. ON THE INCIDENT DATE, AFTER APPROXIMATELY 0800 HOURS, MR. SANTIESTEBAN HEARD LOUD NOISES HE RECOGNIZED AS GUNSHOTS.

UPON EXITING HIS APARTMENT, MR. SANTIESTEBAN LOCATED MR. BIOTTE LAID OUT ON THE 1ST FLOOR OF THE APARTMENT BUILDING AND SUFFERING FROM AN APPARENT GUNSHOT WOUND TO HIS ABDOMEN. MR. BIOTTE STATED "307, THE ONE FROM 307", IN SPANISH, AS MR. SANTIESTEBAN ATTEMPTED TO PROVIDE FIRST AID. MR. SANTIESTEBAN ALSO STATED HE OBSERVED AN EXPLOSION AFTER HEARING THE GUNSHOTS.

AT APPROXIMATELY 1137 HOURS, MR. LAMOTH PROVIDED A SWORN AUDIO RECORDED STATEMENT TO DET. BARRETO AND DET. V. FERNANDEZ (#42649). MR. LAMOTH CONFIRMED HE WAS A RESIDENT AT THE INCIDENT LOCATION. ON THE INCIDENT DATE, MR. LAMOTH HEARD LOUD NOISES AS HE WAS WALKING DOWN A STAIRWELL. UPON EXITING THE STAIRWELL, MR. LAMOTH OBSERVED A MALE RUN PAST HIM AND EXIT THE BUILDING. DURING THE INTERVIEW, MR. LAMOTH DESCRIBED THE MALE AS THE RESIDENT OF APARTMENT #307.

A RECORD CHECK VIA THE DRIVER AND VEHICLE INFORMATION DATABASE (D.A.V.I.D.) REVEALED THAT THE RESIDENT OF 431 N.W. 3RD STREET APARTMENT #307 IS MR. JUAN FRANCISCO FIGUEROA (DEFENDANT). MR. FIGUEROA IS ALSO THE REGISTERED OWNER OF A HONDA ACCORD, MAROON IN COLOR, BEARING FLORIDA TAG #BS54SH.

AT APPROXIMATELY 1507 HOURS, DET. S. LLANES (#44858) ADMINISTERED A SEQUENTIAL PHOTOGRAPHIC LINEUP TO MR. SANTIESTEBAN IN WHICH HE POSITIVELY IDENTIFIED MR. FIGUEROA AS THE RESIDENT OF APARTMENT #307.

AT APPROXIMATELY 1556 HOURS, TACTICAL ROBBERY UNIT (TRU) DET. J. GIL (#41325) AND CITY OF MIAMI POLICE OFFICERS CONDUCTED A TRAFFIC STOP ON A HONDA ACCORD, MAROON IN COLOR, BEARING FLORIDA TAG #BS54SH. MR. FIGUEROA WAS LATER PLACED INTO CUSTODY UNDER CITY OF MIAMI POLICE CASE NUMBER 240610-0040165. SEARCH INCIDENT TO ARREST, A 5-CYLINDER REVOLVER WAS FOUND ON HIS PERSONS. THE FIREARM IS A SMITH & WESSON, MODEL 36, .38 SPECIAL CALIBER WITH A SERIAL NUMBER #ADV4304. OFC. LAVERNIA THEN TRANSPORTED MR. FIGUEROA TO THE CITY OF MIAMI POLICE DEPARTMENT VIOLENT CRIMES UNIT FOR AN INTERVIEW.
