On the 20 day of JUNE, 2024, at 00:44 at 300 ALTON RD DOCK D. MIAMI BEACH, FL, 33139

OFFICERS RESPONDED TO 300 ALTON RD DOCK D REFERENCE A DISTURBANCE ON ONE OF THE YACHTS. PER DISPATCH, THE COMPLAINANT STATED THAT THERE WERE PEOPLE FIGHTING ON THE VESSEL.

UPON ARRIVAL, OFFICERS OBSERVED THE DEFENDANT, LATER IDENTIFIED AS JACQUES BERMON WEBSTER II STANDING BY THE DOCK YELLING AT THE VESSEL OCCUPANTS. OFFICERS MADE CONTACT WITH THE DEFENDANT TO CONDUCT AN INVESTIGATION. THE DEFENDANT WAS ASKED BY OFFICERS TO SIT DOWN AT WHICH POINT THE DEFENDANT TEMPORARILY SAT DOWN AND THEN BEGAN CONTINUOUSLY STANDING BACK UP DISREGARDING OFFICERS COMMANDS. ON SCENE COULD SENSE A STRONG SMELL OF ALCOHOL COMING FROM THE DEFENDANTS BREATH. OFFICERS SPOKE TO THE COMPLAINANT WHO STATED THAT HE DID NOT WANT TO PRESS CHARGES AND JUST WANTED THE DEFENDANT OFF OF THE VESSEL. AT THIS POINT, SERGEANT LEMUS TOLD THE DEFENDANT TO LEAVE THE DOCK OR HE WOULD BE ARRESTED. SERGEANT LEMUS ASKED THE DEFENDANT IF HE HAD ANY OTHER PROPERTY ON THE VESSEL TO WHICH THE DEFENDANT STATED "NO". THROUGHOUT THE LONG WALK FROM THE VESSEL TO THE BOARDWALK, THE DEFENDANT WALKED BACKWARDS YELLING OBSCENITIES TO THE OCCUPANTS OF THE VESSEL. IT SHOULD ALSO BE NOTED THAT SOME OF THE VESSELS ON THAT PARTICULAR DOCK ARE OCCUPIED AN IT WAS CURRENTLY LATE NIGHT HOURS.

THE DEFENDANT MADE IT BACK TO A VEHICLE THAT WAS AWAITING FOR HIS DEPARTURE. AT WHICH POINT THE DEFENDANT TOLD ONE OF HIS SECURITY PERSONNEL TO GET OUT OF THE VEHICLE. THE DEFENDANT THEN STATED TO OFFICERS "IF HE GETS IN THE VEHICLE HE'S GONNA CATCH A FADE" WHICH IS SLANG FOR FIGHTING. THE DEFENDANT THEN LEFT THE PROPERTY INITIALLY COMPLYING WITH OFFICERS WARNING TO LEAVE THE PREMISES OF THE MIAMI BEACH MARINA.



NOTE: THERE ARE SEVERAL MIAMI BEACH POLICE NO TRESPASSING SIGNS IN MINIMUM TWO-INCH LETTERING POSTED ALONG THE PREMISES OF THE MIAMI BEACH MARINA. MIAMI BEACH POLICE OFFICERS ARE AUTHORIZED REPRESENTATIVES OF THIS PARTICULAR PROPERTY AND CAN AFFECTUATE AN ARREST UPON DISREGARD OF A WARNING.

THE DEFENDANT RETURNED APPROXIMATELY 5 MINUTES AFTER. OFFICER RODRIGUEZ OBSERVED THE DEFENDANT WALKING BACK TOWARDS THE VESSEL. THE DEFENDANT BYPASSED OFFICERS IN THE PARKING LOT OF THE MARINA DISREGARDING OFFICERS COMMANDS TO NOT GO. ONCE THE DEFENDANT BEGAN SPEAKING TO SERGEANT LEMUS, THE DEFENDANT BEGAN YELLING ONCE AGAIN BECOMING ERRATIC DISTURBING THE PEACE OF THE OCCUPANTS OF THE MARINA AND NEARBY RESIDENTIAL BUILDINGS CAUSING A PUBLIC DISTURBANCE. THE DEFENDANT ALSO DISREGARDED OFFICERS WARNINGS TO NOT RETURN TO THE MIAMI BEACH MARINA.

THE DEFENDANT WAS TAKEN INTO CUSTODY AND TRANSPORTED TO THE MIAMI BEACH POLICE DEPARTMENT.

THE DEFENDANT LATER ADMITTED THAT HE HAD BEEN DRINKING ALCOHOL AND STATED "ITS MIAMI".
